DISCIPLINE

The most important rule for a teacher and a parent to remember, in the area of discipline, is that the adult must control any incidents that give cause for concern. The child must be given the opportunity to develop the self-discipline that is required for social acceptance in a civilized community.

The general limitations of classroom freedom require respect for others and for the environment. Specific requirements are:

1. No physical aggression of any kind.
2. No taking of materials from another either with or without the permission of the child in possession.
3. No interference with work and concentration of others.
4. Never doing for the children what they are able to do for themselves.

Children are expected:

1. To work only with those materials which have been presented to them.
2. To choose their own work.
3. To handle materials carefully and quietly.
4. To return materials to the proper location.
5. To avoid interfering with the work of other children.
6. To be kind to and considerate of all.

The child who repeatedly violates limits may need to sit in an isolated area but will be made comfortable and will be treated gently and lovingly. The attention that the teacher has to give will be given warmly and very quietly. "Isolation" only means withdrawal from the over-stimulating closeness of other children. The child will not be left completely alone but will have the reassuring presence of an adult nearby.

I, the parent or guardian, do hereby acknowledge that the discipline within MAITLAND MONTESSORI SCHOOL, INC. does not include corporal punishment. The method used is time-out for thinking about the behavior and quiet talking to resolve it. The philosophy of Montessori prohibits spanking and works on developing self-discipline within the child.
